Executive Summary

Casinos are frequently touted as job creators. This report compiles data from the American Gaming Association's annual State of the States reports to provide a single source of longitudinal data for casino employment by state and nationwide. It has information for commercial casinos and racetrack casinos, but not Native American tribal government casinos.

As of 2012, 2006 was the high point for national casino employment, with 386,548 total employees. Since then, total casino employment has fallen to 336,272, a decline of approximately 13 percent.
