

CLARK COUNTY GAMING FOOTPRINT, 1963-2017

TOTAL LICENSES, GAMES, TABLES, AND SLOTS

This report charts the changing footprint of the gaming industry in Clark County. Beginning in 1963, we have an unbroken series of records detailing the number of licenses (places where gambling is permitted to be conducted), games (table games and bingo, keno, and race and sports book operations), tables (non-house-banked games), and slot machines.

For almost the entire period, we have information on the breakdown of tables; although now all tables are poker games, the game of pan was popular for many years. Starting in 2013, interactive poker sites are also tracked.

Since 1983, we can track the breakdown of slot machines in restricted locations (15 machines or fewer) and nonrestricted ones (16 or more machines and other games).

Notes and Definitions

All data taken from 4th quarter Nevada Gaming Commission Quarterly Report for its respective year, and is current as of December 31st of that year.

Licenses includes restricted slots only, non-restricted slots only, slot operators, & non-restricted slots and games from 1963-1982; from 1983 onward, also includes manufacturers, distributors, and slot route operators.

Games include craps, roulette, blackjack, baccarat, bingo, keno, race book, sports book, and other casino games.

Tables include poker, pan, gin, and other non-house-edge games; it does not include interactive tables.

Slots includes all slot machines and mobile gaming devices.
