

## DIRECT CASINO TAX REVENUES BY STATE

STATES WITH COMMERCIAL AND RACETRACK CASINOS, 1998-2011

CENTER FOR GAMING RESEARCH, AUGUST 2012

### Executive Summary

Casinos are increasingly being used by states to generate revenues. This report presents, in one place (two charts, though), the total reported tax revenues that casinos—both racetrack and commercial—have generated for states since 1998.

This report does not include revenue-share payments from tribal governments to state governments made as part of compacts, but it does provide a window into how much money commercial gaming interests have generated for states, both on a state-by-state basis and in total.

To see the originals, visit <http://www.americangaming.org/survey/index.cfm> In general, this is a good source, but there are a few inconsistencies (some state revenues are taken for the fiscal, not calendar year).

To enhance the readability of the data, the charts have been broken up into two pages: 2001-2012 and 1998-2008.
